Kum 2008 khan, Aizawla rawng ka bawl lâi, Synod Presbyterian hai Pulpit Bible kha ka'n hnar ve taluo a, ka'n châwk a, Delhi tieng ka phur a, zân tinin ka tiem a, tiem inhawi ka ti bik khawp el a, 'Hmar awngin um ve sien aw,' ka ti a. Anâchu sut tumna lungril khawm ka nei chuong nawh. Biek in bawl hi kan inhnik tak kha a n'a. Nisienlakhawm, hih, Pathien Thlarau inhriettirna ngei a ni ka ring a, kan zâwlpa Dr.Chaltâwnlien Amo-in a lo sut hih, ropui ka ti taluo. A mi surprise a nih. Lalpa ropui raw se.

Khawvêla chanchin dang dang inziekna lekhabu tam tak um sien khawm, (man to tak tak, ha ve tak tak,) chatuon hawl phâk le chatuon dai a um nawh. Pathien thutak BIBLE ruok chu a hring a, thil a thaw thei a, a ringtuhai ta ding chun, ei hringna, ei thlamuongna, ei hrâtna, thlarau phîngâm dangchârna mi sukkhawpui, ei bu inhnik tak, lampui indika mihuoitu le mi kâwkhu tu a nih. "I thu hi ka kehai ta dingin khâwnvar a n'a, Ka lampuia dingin var a nih." a ti thlâwt el hi a n' dik a nih. Pathien thu, Bible hi um naw sien chuh, ieng tawp am ei chang ding hriet phâk an' nawh.

Ei Pathien thu, BIBLE hi ei hriet hne a pawimaw. Ringtu inti a, ei zuk piengthar el kha ei dit tâwk ding a ni nawh. Pathien thu hi ei hriet chieng a pawimaw tak zet. A tam thei ang tak ei byheart hiel khawm a pawimaw tak zet a nih. Kei ngei khawm hin hre tam tâwk naw ka'n tiin ka'n sit ngâwi ngâwi hlak. Eini BIBLE ruok chuh, kawlnâm ngeituo ieng ang nêk khawmin a ngei lem a, chu chau khawm chu a ni le, ru le châng le thling kawi dar khawp hielin a sun thei bawk a nih. A va ropui char char de aw! Ei ru sâng a ei thlin hai chen khawm a zuk sun kawi dar thei chuh a va ropui lâwm lâwm de maw!!! Chu chau khawm chu a la ni nawh, “Lungrila ngaituo le tumhai hi, a hriet nghâl thei a nih.” (Heb. 4:12)-na a khan ei hmu a nih. Chu Pathien thu hring BIBLE chuh ieng leiin am ei ngainat naw ding?
